CONFORM is a Nonionic Surfactant, Penetrant, Deposition Aid/Drift Reduction Agent, Compatibility Agent and Petroleum Oil.

PRINCIPAL FUNCTIONING AGENTS

Polyoxyethylene sorbitan fatty acid ester,
ethoxylated soybean oil,
copolymer of alpha- and beta-pinene..... 100.0%

All ingredients are exempt from the requirements of a tolerance as specified in 40 CFR 180.

Conform is a tank mix adjuvant formulated to provide optimal pesticide performance by enhancing deposition of the spray application. **Conform** contains StorM Technology, an innovative adjuvant technology that has an affinity for pesticide active ingredients. **Conform** suppresses off-target drift of spray applications by providing a more uniform pattern and velocity of the spray droplets. **Conform** can be used with air assist and conventional spray nozzles. **Conform** can be used with herbicides, including desiccants, insecticides, fungicides and plant-growth regulators, in keeping with pesticide label recommendations. **Conform** maximizes pesticide performance by improving spray coverage and through enhanced retention and infiltration of the targeted leaf surface. Many factors affect off target drift such as spray boom height, nozzle configuration, spray pressure, temperature, wind and thermal inversion. **Conform** will not eliminate all drift. **Conform is not for aquatic use.**



HAZARD STATEMENTS

- Causes serious eye irritation.

PREVENTION

- Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco.
- Wear protective eyewear (goggles or face shield), chemical-resistant gloves, long-sleeved shirt and long pants, shoes plus socks when mixing or applying **Conform**.
- Do not eat, drink or smoke when using this product.
- Avoid breathing dust, fume, gas, mist vapors or spray.
- Use only outdoors or in a well-ventilated area.

FIRST AID

- **IF IN EYES:** Rinse continuously with water for several minutes. Remove contact lenses if present and easy to do; continue rinsing. If eye irritation persists, get medical advice/attention.
- **IF INHALED:** Remove victim to fresh air. Keep patient warm and at rest. If breathing is irregular or stopped, give artificial respiration. If unconscious, place in the recovery position and obtain immediate medical attention. Give nothing by mouth. Call a poison center or doctor/physician if you feel unwell.
- **IF SWALLOWED:** Obtain immediate medical attention. Keep at rest. Do NOT induce vomiting.
- **IF ON SKIN:** Remove contaminated clothing. Wash skin thoroughly with soap and water or use a recognized skin cleanser. Do NOT use solvents or thinners. Wash contaminated clothing before reuse.

DIRECTIONS FOR USE

Always read and follow label instructions of accompanying pesticide product before using **Conform**. The addition of an adjuvant to some pesticides may increase the risk of phytotoxicity to certain susceptible crops, especially during periods of high humidity or other circumstances which may increase the activity of spray solutions. Care should be exercised when using on new varieties or crops not previously treated with **Conform**. **Not for aquatic use.**

MIXING INSTRUCTIONS

Add **Conform** after pesticides or other adjuvants are introduced to spray mixture but prior to completing the filling of the spray tank. Before making large scale applications, conduct a jar test containing all ingredients to confirm compatibility.

FOR DIRECT INJECTION
<p>Conform can be applied through injection systems when added to one of the system's chemical injection tanks. An in-line mixing chamber is recommended.</p> <ul style="list-style-type: none">• First, add Conform to the chemical injection tank;• Second, pump the correct amount of Conform into the line;• Third, pump the proper amount of water, pesticide, fertilizer and other adjuvants into the line, for mixing with Conform and chemicals, before going into the spray boom.

STORAGE, DISPOSAL AND SPILL

- Do not contaminate water, food, or feed by storage and disposal.
- **STORAGE:** Keep this container tightly closed and store in a cool, well-ventilated space. Store above 25° F. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment washwater, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame.
- **DISPOSAL:** Triple rinse container and pour rinsate into spray tank. Do not reuse container. Offer triple-rinsed container for recycling, or puncture and dispose of in a sanitary landfill or by other procedures approved by appropriate authorities. Dispose of contents/ container in accordance with local/national regulations.
