DIRECTIONS FOR USE

SeedStart Hera is designed for use in seed treatment, in-furrow, and foliar applications. SeedStart Hera is intended for use on all cereal grain, row, legume, vegetable, and grass crops. SeedStart Hera should be used in accordance with the recommendation of a qualified person or institution such as a certified crop consultant or agronomist. SeedStart Hera can be applied in combination with other pesticides. When combining with other products, a standard jar test is always recommended.

Always shake well before use. Totes and drums should be mixed prior to use and at least every 3 months during storage. For smaller packages, shake before use.

SEED TREATMENT APPLICATION RECOMMENDATIONS

SeedStart Hera can be used with standard seed treatment application equipment. Ensure uniform application.

RATE APPLICATION

Seed Treatment: 0.5 – 2.0 oz./cwt.

In-Furrow: 2.0 – 8.0 oz./acre

Foliar: 2.0 – 8.0 oz./acre
