PRINCIPAL FUNCTIONING AGENTS

M-90 is a nonionic surfactant formulated for increasing the efficacy of various agricultural and horticultural spray applications. **M-90** should be used where wetting and uniform coverage of the spray is required. **M-90** is not for aquatic use.
